## **Celebrity News: Jodie Sweetin's Ex-Fiance Justin Hodak Sentenced to 6 Years in Prison**

There's nothing, but trouble for former [celebrity couple](#) Jodie Sweetin and Justin Hodak this week in [celebrity news](#)! According to [UsMagazine.com](#), Hodak has recently been charged with illegal possession of a deadly weapon and threatening a witness with force. He will serve almost seven years in prison, and will then be on probation for five years following his release. Now that the [celebrity exes](#) have called it quits following Hodak's several arrests and violation of the restraining order Sweetin took out against him, Hodak must not post any photos or videos of Sweetin or risk violating the terms of a protective order. He must also complete a 52-week program on domestic violence upon the conclusion of his sentence.
